By utilizing minimally invasive techniques, our team of highly skilled interventional radiologists are able to deliver targeted treatments for a wide variety of cancers, arterial disease, blood clots and more. Patients who undergo interventional radiology procedures have less risk, less pain and shorter recovery times than standard surgery.

SERVICES

- Angiography – diagnosis and treatment including peripheral vascular disease, peripheral aneurysms, arteriovenous malformations and renal angiomyolipomas
- Ablative Therapies – cryoablation, microwave and radiofrequency ablation of renal, liver, lung and bone tumors
- Chemoembolization – arterial embolization of hepatocellular carcinoma and metastatic disease to the liver
- CT and ultrasound guided biopsies
- DVT thrombolysis and IVC filters
- Gastronomy tubes – enteral access
- Gonadal vein embolization – Pelvic congestion syndrome and testicular varicoceles
- Hemodialysis access – catheters, fistulagrams and fistulalysis.
- Kyphoplasty and vertebroplasty
- Port catheters
- Thoracentesis and paracentesis
- Uterine fibroid embolization
